From the Presidents' Desk

It's 2013, time for a new year. Hopefully we can look forward to some fun at the lake. 2012 was an emotional year for many. Things were said and done that will continue to cause hard feelings among friends, neighbors and perhaps even family members. I must be getting old because I look back at the days when we could get together with other members for a cup of coffee or a cold drink and during long conversations, disagree about anything and everything, and still look forward to getting together again the following week with no hard feelings. Now, in the days of the impersonal conservations of Facebook, if you don't agree with me, I will unfriend you for life.....OMG! If you want to be my friend, you must send me a request to do so. I will then think about what statements you have made or things you have done, and maybe grant you your wish. Just remember though, that the approval is only temporary and you can be "unfriended" at any time. With the power of the internet, and the push of a single button, your ideas, concerns, complaints, etc. can be shared with everyone. Last year the board received numerous complaints from members that no longer want to share their email addresses with anyone due to the negative, and sometime childish, messages being sent. I assure all members that in the future your email will only be used for official association business. If you receive any unwanted message from another member, I suggest you take up the concern with that member. It is important that we do have your email address to avoid postage and copying costs of minutes and other necessary information. Many other lake associations distribute a membership list with names and lot numbers only and no personal information such as address, phone # or email. Perhaps this should become the new policy of Melody Lake Association.

For years the association has been run as if it were a social organization, a place to relax and enjoy while keeping the rules to a minimum. In late 2012, the board was reminded that we are a Not For Profit Corporation and bound by a certain set of laws in New York State. A small group of members decided that they were not happy with the way things were going and filed an 18 page complaint with the NYS Attorney General's Office alleging certain statements and events over the past 6 or more years. Although the exact allegations were not made known to the current

board of directors, the Attorney General suggested that we attempt to resolve the issues among ourselves and limit additional legal expenses to the association. Last October, the board sent a letter to those concerned members addressing the allegations that we were aware of but have yet to receive any comments back. We will continue to do whatever we can to address the allegations while also attempting to keep any legal expenses to a minimum. While doing this we will also attempt to keep Melody Lake a fun place to enjoy and relax. In the meantime all past, present and future officers, as well as all association members, must be reminded that there are rules to be followed for all of us. The board members must remember that all NYS Not For Profit Laws must be followed. All property owners must also remember that even though Melody Lake is a private lake, there are fishing, hunting and boating laws to be followed. There are also various permits necessary from the Town of Willet, Cortland County, New York State, and maybe even the Federal Government before certain improvements can be completed on your property. Included in this newsletter are some of the guidelines for you to follow to avoid trouble with the law. All it takes is one person to cause an expensive problem for you or the association.

If you are not happy with the way things are being run, please come to the meetings and let your voice be heard. Better yet, remember that the election of officers will be held late this year for 2014 -2015.

A FEW WORDS FROM JOHN OPP

The lake life offers many opportunities to connect with people. It seems that this past year my wife and I made some strong connections with people that we didn't previously know all that well. It is fun to make new friends. Conversation on the beach (low water has its benefits), fireside chats with a cool beverage, walks around the lake on a regular basis, work crew interaction on needed projects (more to follow), are all just samples of positive things the lake has to offer. We are looking forward to more of that interaction this coming year. For the new owners and members, take time to introduce yourself to your neighbors and others around the lake. Make some new friends.

We did finally complete a couple of much needed projects on the lane this past year. The drainage culvert under the lane at the power line will hopefully continue to relieve the water problems down by the Ginn's and Laurie Peloso on the lake side. The culvert replacement under the Wilbur's driveway showed preliminary results of improving the situation, however we do know that the lane and ditches from the Wilbur's to the large drain culvert, going out the lane, which was replaced a couple years ago are level with hardly no drop in elevation. Water does not run well there. There are two other driveways in between with culverts that are mostly plugged or collapsed, and we will look at replacing those in the future. We need to improve the ditch slope to improve drainage. It is the responsibility of each member on the lane to clean the ditch bordering their property to ensure proper drainage. Clean out the weeds and root growth and make sure the water will drain away. It is preferable that you do it before the association has to take action at an added expense. At the dam, the gabion basket on the east bank side was filled with help of several members. Large stone was obtained that will not wash out, and some stone and concrete packed in strategic places to control erosion. The necessary paperwork was filed with the state to close their immediate concerns over these items. We will continue to monitor these and all aspects of the dam to ensure it remains sound and respond when things need our attention. Continued maintenance can only have a positive impact on the upcoming engineering analysis to be completed in 2014. Plus we are subject to surprise inspections by the state DEC.

As all members are aware, the board is comprised of elected members serving on a voluntary basis to manage the business aspects of the association, and to ensure that the association by-laws are upheld, as well as laws applicable to us as a not-for-profit corporation under New York State law. The board is also seen as the enforcer of rules and regulations and some of that has positive impacts or negative impacts, depending on the situation. In making decisions sometimes things like exposure to risk and liability under our insurance protection need to be considered, along with long standing precedent set by the record of previous membership in years past. This can also include potential consequences of risk exposure to all members on issues they may not be aware of but would not want that exposure whether they know about it or not. Above all, the actions of the membership should be fairly and consistently applied to preserve or protect the best interests of the association and all members. The board will continue to make the members aware of issues that may have an impact on them and reserve the final decision for these issues to be made by a vote of the members. It is important to attend the regularly scheduled meetings to make sure you are kept aware on a timely basis and can have a say in matters that may impact you or your property at the lake.

MELODY LAKE.....Thru the Years by Bob Rosati

It all started out long before there was a Melody Lake or even a Town of Willet. The first white settler to the area was Ebenezer Crittenden in 1797. Originally from Barrington, Mass. he was married in Binghamton and set out with his new bride on their honeymoon cruise in a canoe type boat with one paddle and one pole, up the Tioughnioga River and then up the Otselic River. They would remain the only white settlers for the next 9 years. The Town of Willet was formed on April 21, 1818. Fast forward about 50 years or so to the small Hamlet of Georgetown which was located at what is now the intersection of German Rd and Rt. 41. This was the location of Burlingames Mills which was most probably a sawmill. Soon after a grist mill was built. To power these mills a steady and reliable source of water was needed. To provide this, a dam was built at an upstream swamp, forming what is now Stump Pond. As Georgetown grew so did the mills, along with the need for more water. A dam was then built at another swamp upstream of Stump Pond. This would form Ellis Pond (now Melody Lake). A town map dated 1876 shows 3 residences on Melody Lake Rd. They were J.D. Greene (on the north side of Melody Lake Rd near the dam); T.L. Sternberg (now Bill Matola/Brian Norris) and I. Leach (now Dan & Debbie Walker). Over the next 70+ years the properties would change hands several times and in 1952, the lake and most of the land around it would be owned by Neal and Margret Potter. In the late 1950's Mr. Potter decided to subdivide some of the property around the lake. A subdivision was approved by the Cortland County Health Dept on July 10th, 1958 and the first lot (#14) was purchased by William and Ruth Carmen (now Joe and Cindy VanAtta). The second lot to be sold was lot #90 to Virginia Skelly (now Dennis and Sue See). In July 1964 another subdivision was approved resulting in additional property around the lake to be developed. As development increased, it became obvious that some type of oversight was necessary to monitor what was going on around the lake and an informal association was formed. All property owners were asked to donate \$5/year for upkeep on association property. After a few years trying this, it was decided to form a formal association and incorporate. (we've skipped over a lot of local history, but let's save that for a future newsletter).

Now let's look at some important dates for Melody Lake Association, Inc.......

June 22nd, **1964** Melody Lake Association, Inc. was formed. ByLaws were adopted which called for all members to pay \$5.00/year dues but also failed to make membership mandatory.

August 1965 – The lake, dam, 9 rights of way, and Melody Lane were deeded to Melody Lake Association, Inc by Neal Potter.

May 23rd, 1968 – A large portion of land on Melody Lane opposite lots 1275 thru 1287 was donated to the association by Bill and Jerry Hudick (now Wohlgemuth).

July 1968 – Lake was stocked with 400 bass

1969 – Lake was stocked with 200 channel cats, 160 bass and 300 yellow perch

1971 – 200# of copper sulfate was applied throughout the lake in an attempt to control weeds. This practice continued thru 1980.

August 1971 – Dues were raised to \$10/year and bylaws were changed to make membership mandatory. Dues would be used for (1) stocking the lake with fish, (2) weed control, (3) dam maintenance, (4) purchase of gravel for Melody Lane maintenance, (5) liability insurance for association property.

1972 – Multiple complaints were received by the Cortland County Health Dept regarding faulty outhouses and septics (current regulations require all outhouses to be at least 50' from a body of water).

1974 – lake was stocked with channel cats, bullheads and perch

1975 – lake stocked with 200 channel cats, 300 bullheads and 100 northern pike. Melody Lane was treated with 20 bags of calcium for dust control

July 1976 – Melody Lake Association purchased 4.16 acres located at the end of Melody Lane for \$6500. This included the final 209' of lake frontage that was not controlled by the association. Dues were raised to \$20/year to cover the 10 year mortgage, additional insurance and taxes

1980 – lake was stocked with 150 channel cats, 150 Oswego bass, 150 crappies, 100 yellow perch and 200 snails. In the summer of 1980 the association decided to try to drag chains, and even a bed frame behind boats in an attempt to get rid of the weeds in the lake. Since this did cut the weeds, but did not harvest the cuttings, it only made the weed density worse.

1981 - the association purchased a small sickle bar weed cutter which was used until 1985. Once again, this cut the weeds but did not harvest them. The weed cutter was sold in 1988.

Sept 1981 – the association was informed by NYSDEC that as the result of a Phase 1 Army Corp of Engineer inspection, Melody Lake Dam was found to be unsafe due to an inadequate spillway capacity and lack of an operable drain and ordered to retain the services of a professional engineer (PE) to correct the deficiencies within 12 months. An estimate from a PE put the cost at more than \$250,000. The association attempted various fundraisers such as garage sales, chicken bbq, flea markets, etc. which did raise some funds. In 1986, it became obvious that DEC was getting impatient from the lack of any progress being made. Several association members got together and agreed to offer a more reasonable and affordable correction to the concerns. A proposal was made to DEC in June 1986 which was approved in August 1986. Throughout the winter of 1986, bids were sought and in early 1987 the lake was lowered 7 feet and construction started. To pay for the necessary construction, all property owners were assessed \$600. More than ¾ of the members paid and then the association hired Atty. Edmund Hoffman in Cortland to write to the remainder threatening legal action. Eventually all members but one paid the assessment. Much of the prep work, demolition, tree cutting, etc. was completed by over 2,500 hours of association member volunteers. The installation of the drains, along with the final concrete work, was performed by hired contractors. The project was completed in the fall of 1988 at a cost of less than \$60,000. A letter was received from DEC stating that "the dam now meets all current requirements of a high hazard dam" and goes on to say "you and your members should be commended" for the work completed. (if you would like to see the pictures of this project contact President Rosati)

August 1984 – a motion was made and approved to develop a permanent access road thru the "pasture property" from the end of Melody Lane to the western boundry of Association property to allow vehicle access to two properties near the dam (now Accardi and Atutis).

1987 – Melody Lake Association joined New York State Federation of Lake Associations (NYSFOLA). Water quality testing became available through a DEC program called Citizen Statewide Lake Assessment Program (CSLAP). Initial test results showed that the lake had an extremely high level of phosphorus which was probably the main reason for our negative aquatic vegetation problem. A survey sent to all property owners showed that the #1 complaint was the high density of nuisance vegetation

1989 - 400 Largemouth bass were stocked into the lake

1990 – DEC received numerous complaints regarding property owners using motor oil to control dust. All members received a letter from DEC advising them that this was not allowed.

July 1991 – dues were raised to \$30/year.

1991 – an over population of stunted perch and sunfish became a concern. In an attempt to alleviate the problem, 1000 walleyes were stocked each year thru 1993.

June 1992 – a survey showed that a mobile home owned by the McGraths at 1290 Melody Lane (now Bernard) was partially on association property. Due to liability concerns, discussions between the association members, the property owner and his attorney proved futile and no agreement could be reached. The end result was that the mobile home was relocated and is now totally on private property.

August 1995 -John Peverly, from Cornell and and a member of the NYSFOLA Scientific Advisory Board identified the major problem was Eurasian Milfoil. It was obvious that past measures of control had failed and the membership couldn't decide on how we should attempt to control the weed.

May 1997 – 175 grass carp were stocked in the lake to attempt weed control. This project was paid for by an "Adopt A Carp" program resulting in no cost to the association.

1999 – as a result of a few members attempting to cut weeds with various handheld cutters the weed density was only getting worse. A motion was made and approved that no aquatic vegetation control could be done without the approval of the association.

2001 – the association was given an \$8000 grant from DEC and NYSFOLA to prepare a "State of the Lake" report describing the past and present condition of the lake, and a "Lake Management Report" describing the steps we planned to take to improve the water quality of the lake. **(for copies of these reports contact President Rosati) 2001** – for the first time the paid membership of Melody Lake Association was 100% (90 members)

2002 – Many members voiced concern that the grass carp were not controlling the nuisance weeds as quick as they expected. It was decided that we should invite representatives of various vendors and give them an opportunity to "sell" their product. The Sept 2002 meeting was held at the Willet Town Hall. In attendance were representatives of companies specializing in chemical, mechanical and biological aquatic vegetation control. Each representative was also offered one page free in the 2003 newsletter to explain their product. When it was all said and done, it was decided to continue with the grass carp program.

2004 – the association approached the Town of Willet and the State Police regarding uninvited people from parking on Melody Lake Rd and fishing in the lake. The State Police stated that they were not going to attempt to check membership status but would enforce a no parking law if one were put into effect. The town would not agree to a seasonal no parking law but suggested a year round no parking law. A public hearing was held with no negative comments and in 2005 a no parking law was put in place along Melody Lake Rd from the intersection of Melody Lane to the dam.

Sept 2004 – Association member Tami Darrow-Zebrowski suggested a "Save the Lake Fund" to allow the fellow members to donate additional money that would be used specifically to improve the quality of Melody Lake. The fund was started with a \$1000 donation from Tami along with an additional \$15 from bottle and can deposits. Since that date Tami has donated more than \$100 annually.

2005 – the association was made aware of a gate being erected on Forshee Rd which blocked our secondary access to the dam. The association attempted to work with the town to try and get the gate removed. From 2005 thru 2012, the association would spend several thousands of dollars for this and other lawsuits resulting from accusations against various members and officers of the association.

August 2005 – a motion was made and approved to establish a Dam Fund in the amount of \$100/member.

Sept 2005 – a motion was made and approved to raise the dues to \$60/year starting in 2006

July 2006 – 350 more grass carp were stocked into the lake, again at no cost to the association.

2006 – association member John Opp donated proceeds from land sales and unsold land to the association worth about \$6000. Over the years the land would be subdivided and sold to adjacent land owners which allowed them to additional property. This property also served as a buffer to protect the lake from future development.

Feb. 2008 – NYSDEC announced a proposal to update the NYS Dam Safety Regulations. Since Melody Lake Dam is considered a Class C, High Hazard dam, if the proposed regulations were adopted, it may have been more than we could afford. The association joined forces with NYSFOLA and other dam owners across the state and wrote letters of concern. The association also sent representatives to public comment meetings throughout the state.

August 2009 – DEC adopted a scaled back version of revised dam safety regulations. Under the new regulations, the association must (1) prepare an Annual Certification to DEC, (2) Prepare an Emergency Action Plan by 8/2010 with updates annually, (3) Perform periodic Safety Inspections, (4) conduct an Engineering Assessment by 8/2014. Items (2), (3) & (4) must be completed by a Professional Engineer (PE).

2009 – Dues were raised to \$100/year to help pay for legal expenses.

January 2011 – the association was served a summons to appear in court to answer charges by neighboring property owners stating that they were "seeking relief and restitution for the time, work and money we have spent defending, repairing and protecting our property and family from a continuing campaign of belligerence that has been waged against us by the members of Melody Lake Association". Rather than pay additional legal expenses, the current board chose to appear in court and defend the association. The alleged charges were that on several occasions, past association officers harassed and ridiculed their families by trespassing and refusing to leave, taking pictures of their children, giving them the finger, torn down posted signs and many other accusations. After the current board presented the association's view, the judge agreed that even if the incidences had occurred, they were done by individuals and even though they were board members, they were not representing the association at that time. All charges against the association were dismissed.

2011 – by the end of 2011, all property owners had paid their dues except one. Due to personal matters, this member had also not paid for the past 5 years, along with the \$100 dam fund. A decision was made to attempt to collect, which failed. It was then decided to proceed to small claims court. Negotiations just prior to presenting the case before the Town of Willet Judge, resulted in an agreement being reached and all monies due the association were paid. **Sept 2012** – the association members and officers were advised that a small group of members had filed an 18 page complaint with the NYS Attorney General's Office against the current officers. Although the full list of accusations were not disclosed, in an attempt to avoid further legal expenses to the association, the board addressed, in writing, the

concerns they were aware of. We are still awaiting a reply to assure that all concerns have been addressed.

In the last 3 pages, we have looked at the past of Melody Lake Association. Now let's look at the future. Next year, 2014, we will celebrate the 50th Anniversary of the association. During these 50 years, we have had our share of ups and downs. We have had a membership of only 40% but for the last 6 years can brag about 100%. In fact, last year, due to the generosity of some of our members, dues exceeded 108%. For the most part, we are one of the most successful lake associations in the state. In 1992, our association was used as an example of the problems faced by the typical not for profit small dam owner in a publication by the US Army Corp of Engineers. Just last year in 2011, an article in ClearWaters, a magazine of New York Water Environment Association, Inc. had an article about Melody Lake titled *Lake Association Works for Dam Safety – Vital issue to Downstream Citizens*. A copy of each of these articles is available. Several times each year, we are contacted by other lake associations asking our advice on many of their problems. We have a right to be proud when we say we are a member of Melody Lake Association. If you have any ideas on how we can celebrate our 50th Anniversary in 2014, please let us know.

DON'T FORGET THE PERMITS

Over the past several years, property owners have made improvements or modification to their property or shoreline. We would however like to remind you that many of these things require a permit. While it may sometimes be easy to complete the job without being noticed, there are some very stiff and expensive penalties if you get caught. While the association can't offer you advice when a permit is required, we can lead you to the right people to answer your questions. Don't rely on your contractor or neighbor because they are not the ones that will be paying the fine.......you will! In an attempt to protect the lake and the property around it, the association has formed a partnership with the Cortland County Health Dept. so when a permit is applied for the association will be notified. We are in the process of entering into a similar partnership with both the Town of Willet and the New York State Dept of Environmental Conservation.

Town of Willet: Many home improvements such as buildings, decks, sheds, etc. require a permit. If you have any improvement planned in the near future contact the Town Clerk at 863-4877. You might get an answering machine but someone will get back to you.

Cortland County Environmental Health: A permit is required for all new installations and many repairs or modifications to both your septic and well. If you have anything planned, please call (607)753-5035.

New York State Dept of Environmental Conservation: Over the past several years, many lakefront property owners have been placing gravel or peastone in the lake. Some have even built "seawalls" or "breakwalls" made of concrete, stone or wood. All of these types of improvements (?) require a permit from DEC and perhaps the Army Corps of Engineers. Environmental Conservation Law (ECL) 15-0505 states that – no person......shall excavate or place fill below the mean high water level of any navigable waters of the state without a permit issued by the department. This fill shall include but not limited to earth, clay, silt, sand, gravel, stone......or crib work of wood, timber, logs, concrete or metal. The mean high water mark for Melody Lake is 1402" and anything that touches the water when the lake is at the spillway elevation is in violation of that regulation. Also remember, your property line ends at the waters' edge and any fill or excavation beyond that point may be considered trespass. If you have any plans to place anything in the lake please contact NYSDEC Permits in Cortland at (607)753-3095 ext 235. In addition, since the association is the legal owner of the lake at 1402' elevation, it also requires approval form the association.

REMEMBER, ALL THESE PERMITS TAKE TIME TO PROCESS AND NO WORK CAN BE STARTED UNTIL THE PERMIT IS APPROVED.

If you know of any other wine makers, please ask them for a couple bottles to include. Further details (time, place, etc.) will be announced at the first association meeting on June 9th, 2013. All proceeds will be donated to the association.



IT'S THE LAW!!!

Open Burning:

On October 14, 2009 NYSDEC regulations became effective prohibiting all open burning in NYS. This includes the burning of household trash and yard waste. There are some exceptions such as:

- Small cooking fires or camp fires, using only untreated wood. Any campfire must be less than 3' in height and less than 4' in length and diameter
- The burning of downed limbs and small branches less than 6" in diameter and 8' in length
- Barbeque grills or maple syrup arches
- No burning of any kind are allowed between March 16th and May 14th

Firewood Transport:

Your firewood may be hiding deadly invasive pests that have already killed more than 50 million trees in neighboring states. These pests include but are not limited to both the *Asian Longhorned Beetle* and the *Emerald Ash Borer*. It is now illegal to bring any untreated firewood into New York State. It is also illegal to transport untreated firewood more than 50 miles from its source. If you transport any untreated wood from within the allowable 50 mile radius you must be able to provide proof of its source (such as a receipt) or be subject to a fine. For additional information call (866)640-0652 or visit www.dec.ny.gov and enter "firewood" into the search index.

Aquatic Invasive Species:

Over the past few years several invasive species have shown up in the waters of NYS. Even though our lake is private with no main inlet source, it doesn't mean that these problems can't show up here. Many invasive species can be introduced by using fishing gear, boats, kayaks, etc. in other bodies of water and then used without proper cleaning in Melody Lake. Many of these species are microscopic and can be transported on boots, hooks, lures and even fishing line. If possible have separate fishing gear left at your cottage that you only use here at Melody Lake. Many of us take our boats or other watercraft to the local ponds, lakes and rivers. Before using again in Melody Lake, please do a visual inspection to remove any weeds, algae or anything else. Clean with a 2% household bleach solution or scrub with water of 140° and then allow to air dry.

ASSOCIATION FINANCES:

2012 was another successful year for our association. Our 100% membership brought in \$8,300. In addition, many members contributed an additional donation of over \$500. Cortland County Soil and Water paid our NYSFOLA Dues and CSLAP Fees of \$525. They have also agreed to pay the same for 2013.
